The Festival will be held on October 2 & 3, 2020. To help insure the non-profit area is vibrant and serves the purpose effectively, all participating groups are required to staff their booths during the Festival hours, Saturday, October 2 from 10AM to 6PM and Sunday, October 3 from 11:00AM to 5PM.

- **All spaces are approximately 10' x 10'.**
- **Each group is responsible for bringing their own tent, table and chairs. Rental of the above is available for a \$175 fee.**
- **A nonrefundable administrative fee of \$75 is also due with the application. Applications will be accepted on a first-come, first served basis with preference being given to local non-profit organizations.**
- **A copy of your 501 (c)(3) designation letter must be included with this application if it was not provided to us in previous years.**
- **Groups may not share space without prior written authorization from Splash Festivals.**
- **The sale of logo merchandise or memberships may be allowed with prior approval. No food items may be sold or given away. Splash Festivals reserves the right to restrict the sale of any item it deems to be inappropriate.**
- **Norcross Art Splash celebrates the arts and community spirit. Therefore, the promotion of political candidates is prohibited.**
- **By submitting this application, you agree to indemnify, hold harmless, and defend Splash Festivals, Inc. and all of its officers, employees, servants and agents against any and all liability claims, for injury to or death of any person or persons and for loss and damage to any property occurring in connection with or in any way related to or arising out of the occupancy, use of premises or providing of services and equipment at the Festival.**
- **Groups who wish to bring live animals must provide a certificate of insurance with Splash Festivals, Inc. being listed as a Certificate Holder. All animals must be on a leash or caged.**
